I received your letter dated August 26, 2004.

You may have no "present intention" to show the videotapes referenced in my August 26, 2004 letter at the seminar on Monday. However, I am aware that you expressed such intention as recently as August 23, 2004, and that your intention was changed by the seminar moderator's refusal to show the videos in light of the above court order.

As to the videotapes on your clients' website, they are on the opening page of the website, and are difficult to miss. I assume by the "as far as I know" language in your letter, that you have chosen not to look at the website.

The link to Life Legal Defense Foundation and the solicitation letter which offers a copy of the videotape of Terri in exchange for a donation is again on your clients' website. Life Legal is again proclaimed there as the authorized fund raiser for the Terri Schindler Schiavo Foundation.


If you believe that you and your clients have some right to disseminate these videotapes regardless of the above court order (as your letter intimates), please let me know your reasoning. To my reading, Judge Greer's June 27, 2002 Order is quite clear in its prohibition against dissemination of the content of those tapes by counsel, the parties, or the

physicians unless specific authorization is obtained from the court. No such authorization has been obtained.

Please consider this notice of the above matters to both you and your clients, as well as a demand that you and your clients comply with the court's June 27, 2002 Order.
